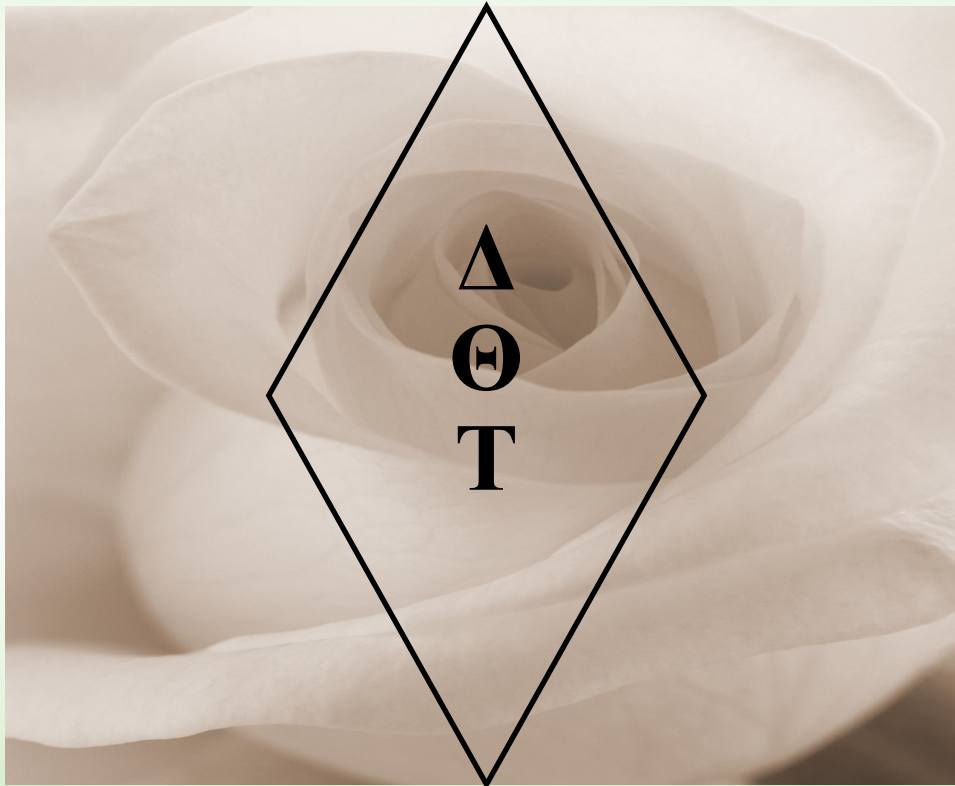

Transportation from the airport: The hotel DOES NOT offer complimentary shuttle. UBER, LYFT, SUPER SHUTTLE, TAXI, TOWN CAR, LIMO all offered from the airport

www.SheratonCrescent.com Convention rate of **\$95.00** plus state & local tax of 12.57%. The hotel rate is good for 3 days pre and post convention. Reservations must be made by **June 19, 2019**. Reservations after that date will be accepted on a space available basis and subject to house rates. The hotel will require guarantee with a major credit card or the first night room deposit, (equal to one night's room rate + appropriate taxes). Each room features one King size bed or two queen beds (floor 1-5 only) or two double beds (please request the type of bed you would prefer) with a sitting area, a mini-refrigerator, microwave, coffee pot and service, hair dryers, iron and full-size ironing board. Some rooms have a balcony, smoking is allowed on the balcony. PROPOSED CONVENTION RULES 2019

1. Credential badges shall be worn at all convention meetings.
2. Members of the convention shall be in their seats five minutes before each meeting.
3. The Sergeant-At-Arms will not admit anyone during roll call and Sorority Ceremonies.
4. A voting member, who finds it necessary to leave a business meeting must leave her credentials badge with the Sergeant-At-Arms, to be returned when she returns to the meeting.
5. The National President may change the order of business when deemed necessary.
6. Main motions and amendments shall be written on a motion form, signed by the mover, and given to the National President, Parliamentarian and the National Secretary for the minutes.
7. Debate shall be alternated between those wishing to speak in favor of a motion and those wishing to speak against it.
8. A voting member wishing the floor shall rise, go to the microphone and address the Chair. After being recognized, give her name, chapter name and city.
9. A voting member of the convention may speak only twice on the same question unless given consent by the assembly. She may not speak the second time if someone who has not spoken wishes the floor.
10. If a non-voting member wishes to speak, she shall ask permission of the Chair and if there is no objection from the assembly, she may speak.
11. Debate shall be limited to three (3) minutes for each speaker. The Board of Trustees shall serve as time keepers.
12. All votes during the convention meeting shall be taken by a voting card unless a revote is necessary.
13. Photography is not permitted during the Sorority Ceremonies.
14. Food is not permitted in meetings or workshops.
15. Business wear only in the convention meeting room; this is defined as business dress, skirt, slacks and capris. No jeans, shorts, or T-shirts are allowed. Exception: DTT t-shirts will be allowed at the Friday morning business meeting and Sunday Installation.
16. During all business meetings, workshops, and committee meetings, all electronic devices and cellular phones will be turned off or placed on a silent/vibrating mode and must be put away (not to be on the table). Use is allowed during breaks only.
17. Pages are available to distribute all notes, messages and any other information.
18. Sales, including approved suppliers, are permitted only in the designated areas.
19. Voting members shall pay a fine to the National Secretary immediately following the close of each meeting for each:
 - \$1.00 for arriving late to any meeting.**
 - \$5.00 for failure to vote at National Election.**
 - \$5.00 for failure to attend any business meeting or workshop(s) unless excused by National Council and Board of Trustees.**
 - \$5.00 for failure to attend the model initiation and/or the installation of officers, unless written excuse is approved by the Presiding Officer.**

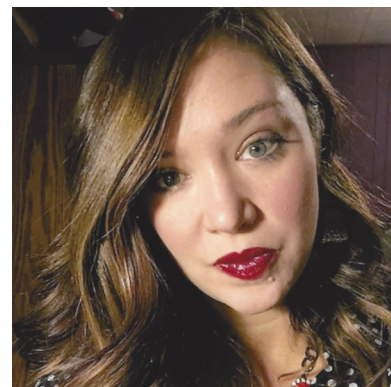
National Vice-President:

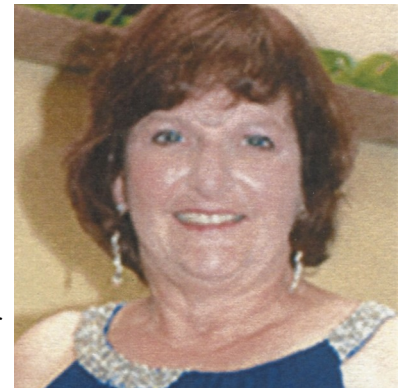
National Treasurer:
