Sew Seeds of Friendship

Perfect Vision Voluntary Project

Since the 2020 National Convention was canceled last year, we did not have an opportunity to do the VSP Eyes of Hope that Bonnie Wells, PNP, had presented in the Spring 2020 issue of GRIT. I would like to carry this over to this year's National Convention. When Bonnie was installed as President, she had an idea to pursue a philanthropy project for National Convention that would not cost anyone any money and will garner us some press. After searching several options, she found VSP Eyes of Hope. This is similar to the Lions Club eyeglass collection project. Eyes of Hope provides collection boxes at convention for free, with postage. All we need to do is clean out our drawers at home and bring old eyeglasses and even sunglasses to convention to drop into the boxes at the Philanthropy Committee Publicity Board.

VSP Eyes of Hope is working together with Doctors of Optometry, community and charitable partners, and public officials to increase access to eye care and eyewear where it is needed most. During recent catastrophes Eyes of Hope partnered with other non-profit aid groups to provide eyewear and exams to survivors.

After **Hurricane Harvey** they helped 750 teachers and educators who were among those who lost everything, Care was supplied by local doctors, all of whom had practices destroyed or damaged.

After **Hurricane Maria** nearly 200 pediatric patients, their families and the hospital staff received eye care and eyewear. Of those patients who received exams, nearly 70% needed prescription glasses.

Following the **Camp Fire**, a VSP Eyes of Hope mobile clinic was stationed in Chico for two weeks to care for those who were affected by the wildfire and support local VSP network doctors whose practices were damaged. In total, nearly 900 people received access to eye exams and replacement glasses.

As of 2018, Eyes of Hope has provided access to free eye care and eyewear globally for more than 2.5 million in need, including 119,000 people affected by disasters in the US.

There is absolutely <u>no cost to the Sorority</u> to do this special project. Eyes of Hope will supply boxes and mailers to send the glasses to them. AND, for our members who would like to participate - **EYEGLASSES WEIGH NEXT TO NOTHING IN YOUR SUITCASE**.

Boxes will be set up in the back of the meeting room for any donations of eyewear, prescription eyeglasses, frames only, or even sunglasses.



We accept complete sets of prescription glasses or readers with plastic or metal frames and intact lenses.

Please note that we can't accept lenses without a frame, broken or damaged eyewear, eyewear cases, or contact lenses.

Please bring your spare glasses to National Convention to help provide vision for those in need

Delta Home Program Directorate



Julie's theme this year is all about "sewing seeds of friendship." Her winter GRIT article talked about how well our Delta sisters are adjusting to the trying times we find ourselves in and forging ahead in spite of everything we face. We are creative and we are strong. We continue to find new ways to work together to accomplish our mission!

Consider the story of the Delta rose shared during our memorial services—that rose found a way to thrive and so have we. As you watch the trees budding and flowers starting to bloom this spring, we want you to take a moment to see if you or any of your Delta sisters may not be thriving financially. Please review the requirements of Delta Home to see who may qualify for this monthly financial assistance program.

So, who qualifies for the Delta Home? She'll need to:

Be 60 or older (Except under exigent circumstances)

Be a DTT member for at least 7 years

Have financial need greater than income

Have paid her Delta Home dues of \$2 per year (Or paid \$100 in lieu of annual payments)

If you or someone you know might qualify, please contact Terri Shannon, Delta Home Directorate President, for an application or to ask questions. Give her a call at 513-255-5043 or email her at shannot1@miamioh.edu. We take great care to make sure every applicant's and recipient's information remains confidential.

After we receive your application, we'll usually let you know if you are approved or not within a few weeks. If approved, assistance can start the following month. We will usually pay one of your bills each month, such as your mortgage, insurance, car payment, or utilities, etc., depending on your financial need. The amount we can provide is based on Delta Home Standing Rules.

Keep in mind that the most common reason a sister is denied is because she is receiving Medicaid assistance. Once a sister goes on Medicaid, Delta Home can no longer help her financially.

This program exists to help Delta Theta Tau members. If you are having trouble paying your bills each

month, please ask Terri for an application. If you see a sister in need, please speak up and let them know about the program. We accept and review new applications year round—so don't delay.

National Philanthropy Committee

The National Philanthropy Committee met on Saturday, January 9, 2021 via Zoom for their Midyear Meeting. Those attending were Ryan Parsons-Rozycki, Chairman; Brenda Moore, Secretary; Linda Dressen, PNP, Third Member; Julie Swoveland, National President, and Mary Beth Godsey, National Secretary of Philanthropy.

The committee reviewed five grant applications. Unfortunately, three of the five were not complete so it was narrowed down to just two applications. Both of those applicants are attending Purdue University Northwest and will both be receiving grant money. Just a reminder to all chapters that if they know someone going into the field of guidance and counseling please let them know that the application is on our website and must have completed application in by December 10th.

Unfortunately, we did not receive any projects for the National Yearly Project. The committee has made a recommendation to National Council that the monies for the National Yearly Project, \$6,700.38, be awarded to NFED since no projects were submitted by chapters this year. Please

remind your chapter that they need to submit a project by December 10th of each year and that information is on our website.

The Convention Delegation voted to donate \$5,000.00 to the National Foundation for Ectodermal Dysplasias (NFED) in 1997 and has been our National Project every year since then. We annually donate \$5,000.00. We all look forward each year in hearing about the research that is going on and how successful it is becoming.

Chapter Delegates, don't forget to bring news articles for the National Philanthropy Committee's bulletin board at National Convention this year.

Hope to see you all there this year since we had to miss last year.

Hotel – Columbus Marriott Northwest has a 4 Star rating and is a newly renovated full-service hotel in the suburb of Dublin. It is in walkable distance to many unique dining options. History of the Delta Theta Tau Memorial Home



DELTA THETA TAU HOME

The information from this article was taken from GRITS 1947-1972, National Minutes and The Diamond Year.

During the 1947 National Convention in Los Angles, California, a letter was read by the National President, Eva Joesting, from Alpha Epsilon Alumnae chapter in which they expressed "a desire for a home for aged Deltas as well as an outline for the building program, which in part as follows:

Since Delta Theta Tau was born in central Indiana, the logical conclusion is that is where the older Deltas are, so we suggest that the first Home for Aged Deltas be located there."

The letter went on to explain what the property would include: an old estate with a wooded area close to a city would be ideal, a large building with a very large dining room, adequate kitchen,

living room, a room with first aid facilities, office space, baths and storage. They also wanted land so that additional cottages could be built when needed. These cottages would be for Deltas who wanted independence but could also have access to the central dining area. At this time it was moved that National Council appoint a committee to investigate the possibilities of a home for aged Deltas and make a report at the next National Convention. This committee was Lura Lee Whitesell as chairman, and members Virginia Bush, Besse Banks Marion, Margaret Klosterman, and Elieen Miller.

At the 1948 National Convention Lura Lee Whitesell, committee chairman presented a five-year financial program for the Delta Memorial Home. The following resolution was adopted by the delegation: "Therefore be it resolved that in this National Convention a financial program to be started for the purpose of establishing a Delta Home and that a five-year plan be worked out of an annual assessment of \$2.00 per capita. The assessment will include all membership. Be it further resolved that funds be used for no other purpose unless otherwise designated by two-thirds vote of the assembly at a subsequent national convention." There was considerable discussion concerning the responsibility of collecting from the membership-at-large and who would be eligible to live in the Home. It was stated by the committee that based on 8000 members at \$2.00 per person per year for five years the fund would amount to \$80,000.00 It was decided that Lura Lee Whitesell would continue as chairman and the committee assigned for this five-year plan were Mildred Stubbs, who had served as national president in 1923, became the secretary of the committee and served in this position for the next 15 years; Nova Vonderschmitt; Eileen Miller; Roberta Scott Minton and Chotsie Hamlett. The motion to accept the resolution was seconded and passed.

The 1949 convention brought numerous amendments to the national bylaws concerning the Delta Home. These amendments came from the Delta Home committee as recommendations. By 1950 convention, \$25.000.00 had been collected for the new Delta Home as Deltas journeyed to South Bend, IN. Mildred Stubbs

moved to adopt revisions to Rules and Regulations which were read at the 1949 convention. The major discussion centered around Alumnae and membership-at-large members who did not want to participate in the \$2.00 assessment for the Delta Home fund during the 1950 convention. A vote was called for - Yes - 74: No -93. The motion was lost and Rule No. 4 stood, Alumnae and membership-at-large would be assessed. With the adoption of the amendments Deltas started paying the \$2.00 assessment during the next vear.

At the Netherland Plaza in Cincinnati 1950, it was reported that Delta Home had a fund of \$45,000.00, and it was estimated by the golden year of 1953 it would have \$75,000.00. It was also





decided that the Delta Home would be a part of our philanthropy and the assessment would be incorporated in the chapter philanthropic report. The search to find missing Deltas who have moved from their original hometowns was enacted by all chapters.

The Delta Home Committee continued to work on the legal aspects as well as with the concerns of the members. They felt "their work would not be successful or progressive without a pre-determined assurance that the issue is sound, practical and possible," as stated by Besse Banks Marion in an article in the GRIT, Summer 1951. It was reported that all officers, active chapters, alumnae associations and Delta Home members were furnished with copies of the Delta Home Rules and Regulations and that all active chapters and 56 alumnae associations had participated in the assessments. A total of \$15,722.00 was collected that year through the \$2.00 assessment.

As the years passed, the amount of money increased in the Delta Home fund toward the purchase of the Delta Manor. The major work was in locating the MAL members who had moved and the sorority had no new address. By the 50th National Convention in Cincinnati, Ohio 1958, the five years of investigation and planning were complete. Two plans were proposed by the committee: Plan 1 a new Building. This plan was based on accommodations for five residents, expansion to be made as required, estimated cost for land, buildings, and furnishings was \$79,200.00 and the minimum cost per resident required to cover room, board, maintenance and operation at this time \$125.00 per mouth per person. Plan 2 The purchase of Delta Zeta House at Green Castle, Indiana which housed 14 residents with expansion possibilities at a cost of \$82,000.00. The cost to resident would be the same \$125.00 per month plus an initial payment of \$5000. At this time the committee felt they were ready to determine how to write applications for entry to the Delta Home. The decision to send a questionnaire and the report of the committee to all chapter presidents, alumnae member and contributing members-at-large was made. It was also decided that the Delta Home Special Gift fund, would provide for the fees any Delta who could not afford the cost. The Special Gift Fund had been established in 1954 for the benefit of members unable to finance their entrance to the Delta Home. This fund is still active today and supported by donations.

By 1959 a property, which was described as "A beautiful property, within the area of some of the first established chapters, is being considered for purchase. Its reasonable cost, in comparison with many of the other property investigations" was decided on as our Delta Home. At the 1959 National Convention in Omaha, Nebraska the Delta Home committee presented a home in Dayton, Ohio. Pictures and a description of the property were on display during the convention for all Deltas to see. In the fall Delta Theta Tau members were invited to our newly acquired Home and the reports of the visitors were very impressive. Beautiful, gracious, charming, and HOME were some of the adjectives used in the GRIT article of Winter 1959 entitled First Impressions. "On Sunday, November 2, immediately following Gamma Province convention in Richmond, Indiana, one hundred and fifty members went to Dayton to tour the Delta Home.... Members of the four Dayton chapters acted as hostesses and guides for the house tour." A guestbook was

signed by all who attended the open house.

Mrs. Charline Rector, one of our founders, was the first resident of our Home moving in August 19, 1960. The Home was also used for meetings and visited often by National officers and members of surrounding chapters. Chapters and alumni within a fifty-mile radius of Dayton were asked to select dates that they wished to "entertain" the residents. Card games, short auto trips, accompanying them to shows, arranging transportation to church or other transportation needs and other forms of simple entertainment were suggested. This time spent with residents could be counted as philanthropy hours for the entertaining chapters. The response to this request was well received. Chapters and alumni were also generous in contributions for the Home, donating items such as books, TVs, and furniture, as well as money to purchase needed items. They wanted this to be HOME.

The 1963 national convention, with the theme, "Delta Dreams," was created by Mary Day, coordinator, and her hostess chapters. There 711 Deltas saw their dreams come true the week of July 17-20 while they were in the city of the Delta Home. That Wednesday afternoon a red carpet was rolled out at 528 Belmonte Park North in Dayton and 500 Deltas toured their new Delta Home. They found they were captivated by a magic quality of their sorority - here was a home they owned. It was theirs for when they would retire, and Mrs. Rector greeted each Delta in her room The Deltas of Alpha chapter, Muncie, dedicated to the founders a six-foot stone fountain on the patio of the estate, while a clump of three white birch trees was planted by the California Deltas. A poem written by Opal Arnold Hambly titled "The Tree Birch Trees," was read by Jeanne Lord and a copy of the poem was framed and hung in the Delta room of the home. (The Diamond Years, Chapter 5, pg. 206)

At the 1967 national convention, the Delta Home Directorate moved to change the name from the Delta Home to the Delta Manor to keep with the type of home that it was "and which express it's origin." The inquiries about the Home continued with all of the promotional material sent out. During the 1968 convention a questionnaire was introduced to the delegation, and was later sent to all chapter, about the number of 60 years or older members. They were trying to determine the possible number of Deltas that would be old enough to apply to be a resident of the Delta Manor. At that time statistics indicated that most active members were under sixty years of age. Of the 1200 forms returned by MALs who contributed to the Delta Home, 450 MALs in the forty to fifty age group stated an interest in the program. Concern was developing over the low number of residents, there were only five residents, and the lack of applications. Mrs. Rector was the first resident to move into the Manor, but after living there for five years, she decided she wanted to live closer to her family.

At the annual meeting of the Board of Directors in September 1968, a report from a consultant in Gerontology was reviewed in order to figure out a way to increase number of residents. A number of proposals had been put into operation and others were being considered for the future guidance and benefit of the Home program. It was highly recommended that we admit non-members for residency until such time as the Manor was needed exclusively for Deltas. This would require revision of the National Bylaws so the Board sent the reasons for the changes and forwarded the information with the revision in mailings to all members. This change also required changes in the investment process. All money was placed in an investment program with the Trust Department of Indiana National Bank of Indianapolis, Indiana. This was explained at the 1970 national convention. Once again chapters were asked to help get the information regarding the procedure and costs to both members and non-members. There were no requests for applications for residency by non-members and only one from a

member that year. The Board was aware of the concern about the economy of operating Delta Manor with so few members, at the time there were only 5 residents. It was decided that at the Board's next meeting it was time to give new direction to the Delta Home Program. It was established that the present facilities at Delta Manor were inadequate to provide the desired services for retirement living and the

services for retirement living and the
Board of Directors would recommend to National Council and Board that the property in Dayton should be sold.
They investigated the possibility of having two homes, one in the west and one in Midwest. Provisions would be made for the residents in Dayton if the home sold before plans were finalized.

The focus during the next year was on selling the Delta Manor and the new direction for the Delta Home Program. Restriction of federal funds and financing slowed the progress of the sale along with a limited market for that type of property. At that time two other ideas were presented for consideration: the possibility of becoming a part of an already established retirement facility which could provide flexible care and which was already operating in several states. The second suggestion came from province workshops and chapter visits. The idea of providing financial assistance to Deltas for residence in homes in their own locale. A survey was sent to all active, associate, alumnae and MALs. The change of the type of facility to financial assistance in their own local residence was complicated because the funds collected for the Delta Home Fund were to be used for a retirement home. The Bylaws of the sorority gave the responsibility of administering these funds to the National Elected Officers and Board of Trustees of the Sorority and Directors of the Delta Home Corporation, but legal statues regulated the manner in which this responsibility may be carried out. The Deltas in charge of these decisions still felt it needed to be the desires of the membership.

The new division of Delta Theta Tau Sorority adopted the name of Delta Home Program Directorate at the 1972 national convention. Immediately following the 1972, the necessary documents were executed to complete the sale of Delta Manor to the Greek Orthodox Church in Dayton, Ohio. The selling price was \$115,000.00 which resulted in a net gain of \$65,000.00. It was also approved by the courts in favor of removing the administrative restrictions of the use of Delta Home Funds for the sole purpose of operating a Home and authorized their use to provide financial assistance to those eligible members of the sorority who had need of such assistance for residency in a licensed home in their own area. This was the end of the Delta Manor project and the beginning of what we now know as the Delta Home Program which is still providing for the well-being of our Delta sisters in need of assistance.

RETIREMENT A WHIRL TO SORORITY FOUNDER

When Mrs. Charles Rector was a high school senior in Muncie, Indiana, she was caught up in what she terms a "gang movement."

"People were getting together to start good will projects," she remembered. "In 1903some of my friends and I delivered Thanksgiving baskets."

Out of this act grew the Delta Theta Tau Sorority.

And even when Indiana law banned sororities in high schools the movement had acquired enough thrust to continue among graduate branches later mushroomed.

Last August the 211 chapters and 15,000 women decided to found a home for retired members.

They decorated and refurnished the former Harry Camby home on Bellmente Park, North.

Delta's founder, Mrs. Rector, fittingly became the first member to occupy the roomy mansion, first sorority retirement home in Dayton, one of the first in the country.

Do busy professional women have as much trouble as men adjusting to retirement? Not Mrs. Rector!

Long ago she learned to extract double mileage from her time. In 1918 Mrs. Rector, mother of three, was awaiting the birth of a fourth child when her husband died of the Spanish flu. After checking alternatives, she decided she could care for her children and pursue a career if she went into teaching. Much of her next 35 years were spent in school teaching or learning. She managed to earn a masters' degree and to educate her four children. Still found time to labor in the far-flung Delta Theta Tau Sorority empire of philanthropy.

Over the years it (philanthropy) included a brace factory, a war orphan adoption program, health and education causes. Trips to the "Betty Troublesome" school in Kentucky found her traveling down creek beds and muleback.

"We gave a mountaineer mother her first china plate. She broke it in two. She wanted each of her daughters to eat from china," the founder recalled.

Today Mrs. Rector is pursuing at least five hobbies with the same vitality that propelled her through her professional years. Her big upstairs room, decorated in robin's egg blue, holds her glass collection and paintings made during travels. A kiln serves her interest in ceramics. For exercise, a walk to town or gardening. As for weekends? There's usually a sorority convention, or the members of Dayton chapters have an outing planned for their most honored member.
