Voting members did not receive 30 days' notice of the proposed amendments to the standing rules, therefore there must be a unanimous vote to consider the amendment. After discussion there was a standing vote. The vote was unanimous.

Standing rules change: Lambda Eta Chapter, Franklin, IN. proposed to change Article V number 2

Plan not less than three (3) social events

Remove the whole sentence and add- Convention may be one-day event with one social function and may be held by electronic means if deemed necessary.

After discussion the question was called and the amendment was defeated.

## Philanthropy Committee

#### **CONVENTION RULES**

- 1. State and Federal COVID guidelines will be followed while in the meeting room.
- 2. Credential badges shall be worn at all convention meetings.
- 3. Delegates of the convention shall be in their seats at least five (5) minutes before each meeting.
- 4. The Sergeant-at-Arms will be instructed not to admit anyone during roll call at each meeting.
- 5. A fine of five dollars (\$5.00) shall be assessed each delegate not in her seat and answering roll call at each meeting, or before it is adjourned, unless excused by the presiding officer. Payment of the fine shall be made to the convention Secretary immediately following the close of the meeting.
- 6. Workshops are considered a meeting of the Province.
- 7. A delegate wishing the floor shall rise, go to the microphone and address the Chair. After being recognized, give her name, chapter city, then state her comment.
- 8. Main motions shall be in writing signed by the maker of the motion and given to the convention Secretary for the minutes.
- 9. Debate shall be limited to three (3) minutes for each speaker. The Province Chairman to designate who shall serve as timekeeper, preferable the Tellers of the convention.
- 10. A voting member of the convention may speak only twice on the same question, unless given consent by the assembly. She may not speak the second time if someone who has not spoken wishes the floor.
- 11. When two-thirds (2/3) vote is required, it may be taken by standing without counting, unless there is a question as to the vote; in which case, it will be a standing count off vote.
- 12. Pages and Tellers shall distribute all notes, messages, or any other information to delegates during the meeting.
- 13. Smoking or Vaping will not be allowed in the convention meeting room.
- 14. Dresses, skirts, capris, and slacks are acceptable attire in the convention meeting rooms, no shorts, jeans, or halter tops. Delta Theta Tau t-shirts are allowed.
- 15. If a non-delegates wishes to speak, she asks permission of the Chair, and if the assembly does not object, she may speak.
- 16. So that all may enjoy the convention, delegates and members of the assembly are requested to refrain from whispering.
- 17. Taking photographs will not be allowed during the initiation or installation ceremonies.
- 18. There will be no children allowed during meetings
- 19. During all business meetings, workshops, committee meetings, and functions, pagers and cellular phones shall be turned off or put on silent vibrating mode. Please refrain from texting and playing games on your personal devices during these same events.
- 20. Delegates must refrain from crafting during the business meeting, workshops, committee meetings and functions. Remember you are a delegate and are here to represent your chapter.

# DELTA HOME PROGRAM DIRECTORATE FACT SHEET August 2021

Eleven (11) individuals are presently receiving assistance. Two (2) of these are Special Gift Fund Only recipients. Sadly, we lost three recipients this past year.

They reside in Arizona, California, Illinois, Indiana, Iowa, Nevada, Oregon.

Total benefits of \$55,777.60 were paid in 2020-21 from the Delta Home Fund. Since the start of the program in 1972, \$3,266,322.00 in benefits has been paid.

Gifts disbursed from the Special Gift Fund totaled \$1,120.00 in 2020-2021. This fund is used for birthday and Christmas presents, chapter and alumnae dues, GRIT subscriptions, National and Province Convention registrations along with unexpected expenses. Donations to the Special Gift Fund are needed so we can continue the level of giving to our recipients that we have done in the past. We have had many donations this past year. Thank you for your continued support.

The Directorate held its annual meeting virtually due to COVID-19 and financial updates were reviewed and the business of the program was completed.

The investments for 2020-2021 were managed by Cadinha Conservative Asset Allocation, Honolulu, HI, NWQ Investment Management Co., Los Angeles, CA, and Jackson Annuities and Insurance. Morgan Stanley Consulting Group, Indianapolis, IN holds the securities.
