# **Roll Call of The Voting Members**

Convention Secretary, Mary Sheldon, called the roll. There were four (4) chapters present as well as eight (8) other voting members. There were twelve (12) total votes possible. The Chair declared that a quorum had been established.

#### Request to be excused from convention

Correspondence was received from Gamma Xi asking to be excused from attending the Delta Province Convention due to member's illnesses and inability to travel. A motion was made by Jenny Wade to excuse Gamma Xi from attending the 2024 Delta Province Convention, it was seconded by Monica Spielman. The motion was voted upon and passed unanimously.

## **Proposed Convention Rules**

Charlotte Marengo, Legislative Committee Member, read the proposed Convention Rules. There was a unanimous vote to adopt the 2024 Convention Rules as published in the program.

#### **Reading of the 2023 Convention Minutes**

The Chair announced that the minutes of the 2023 convention had been approved by the Assigned Officer. No requests were made to read the minutes; therefore, they were not read.

#### **Financial Report**

The Chair presented the <u>draft</u> Province Financial Report. The final report will be sent to the Chapter Presidents and to the National Board and Council once it is completed. As of 10/18/2024 the checking account balance was \$390.08.

## Report of the Legislative Committee/Standing Rules Committee

Yvonne Cabral presented/read the proposed Legislative change:

#### **AMENDMENT 1: ARTICLE II – OFFICERS – Section 1: (b) page 2**

## Present Wording:

The Province Chairman shall be elected by ballot. A majority vote shall constitute an election. In the event there is no election, a second ballot shall be taken on the two nominees having received the highest number of votes. If there is only one nominee, the secretary shall be instructed to cast the elective ballot.

#### Proposed:

Insert after ballot on 1<sup>st</sup> line: at Convention for t two (2) year term. Installation ceremony will only be required on initial year.

Amendment to the amendment, proposed by Lambda Signa, Phoenix, add sentence:

If at the end of the first year the current Province Chairman cannot complete the two (2) year term, there will be a nomination and election at Province Convention for a two (2) year term.

After discussion, a motion was made by Nancy Bain, Epsilon Rho, San Jose, CA to adopt the amendment as amended. Anita Waits, Theta Iota, Delano, CA, seconded the motion. Adopted by vote; eleven (11) in favor and 1 (one) opposed. Newly adopted article below:

## ARTICLE II – OFFICERS – Section 1: (b) page 2

The Province Chairman shall be elected by ballot at Convention for a two (2) year term. Installation ceremony will only be required on initial year. A majority vote shall constitute election. In the event there is no election, a second ballot shall be taken on the two nominees having received the highest number of votes. If there is only one nominee, the secretary shall be instructed to cast the elective ballot. If at the end of the first year the current Province Chairman cannot complete the two (2) year term, there will be a nomination and election at Province Convention for a two (2) year term.

## **Delta Home Report**

Charlotte Marengo, Theta Iota, Delano, CA presented the Delta Home report. She requested that if anyone knows of a member over age 60 who needs financial help please reach out to Charlotte and she will get in touch with that member. She also suggested that we reach out to check on our MAL members who may need support.

# **NFED Guest Speakers**

Brenda Moore introduced guest speakers Sean Vor and his father, Neal Vor. Sean spoke about what it was like growing up with ectodermal dysplasia. He shared that he felt like a normal kid when he attended NFED camps and conferences and that he learned a lot from the older kids who were at camp. Sean said, "you can be yourself and find a support system at camp". Sean is 37 years old now and works in sound design. He is an avid soccer player and is married; he and his wife have two children. His father, Neal, shared what it was like for the family through the process of diagnosis and the challenges they faced and continue to face dealing with the medical insurance bureaucracy. They are both very excited for the new treatments that are evolving since the faulty gene has been identified. Both men expressed their thanks for the continued support that is received from DTT.

Meeting adjourned at 11:58 am for lunch and reconvened at 1:35 pm.

**National Philanthropy Committee Report** 

Jenny Wade spoke on behalf of the philanthropy committee. This year's National Yearly Philanthropy money was split between two projects: Head for the Cure, raising awareness of brain cancer and Sleep in Heavenly Peace, providing children with beds. Each project received \$3,000. Additionally, The National Philanthropy Project, NFED, received \$5,000, giving the organization \$295,248.64 in donation support since 1997. Jenny reminded the chapters in attendance that their chapter projects may be submitted for the National Yearly Project; projects must be on the national level and have a 501 (c) 3 affiliation. Proposals to the National Philanthropy Committee need to be submitted by December 10, 2024.

## **Report of Province Philanthropy Committee**

Anita Waits, Theta Iota, Delano, CA introduced the two province projects to be voted on at this convention: League of Dreams and the Pajama Plus Project.

- 1. Anita Waits, Theta Iota, Delano, CA presented information about the League of Dreams, an adaptive sports league. This is an organization whose mission is to give children a chance to play sports by providing training, team camaraderie, and competitive sporting opportunities to athletes ages 5 to 22 with physical, developmental, and cognitive disabilities.
- 2. Pallie Zambrano, Epsilon Rho, San Jose, CA, and Libby Souter presented information about the Pajama Plus Project. This is an organization that supports children in need by providing essential bedtime items like pajamas, books, socks, and underwear to enhance their well-being, especially children facing poverty, homelessness, or illness.

There was a motion presented from the floor by Charlotte Marengo to vote by written ballot for either:

- A. League of Dreams
- B. Pajama Plus Project
- C. 50/50 split of funds available

The motion was seconded by Bonnie Wells. The motion unanimously carried, and ballots were passed out, collected, then tallied.

Result of vote: League of Dreams -3 votes, Pajamas Plus Project -0 votes, 50/50 split -9 votes. The monies collected will be evenly shared by both philanthropy projects presented at the meeting.

## Workshops
